The Course of Fire will be for “F” class two 20 round strings as listed in the NRA High Power Rule book section 22, 7.16, using the MR-1/w/MR-1FC target. For “G” Class, shooting will be off the bench, firing at the same target as the “F” class shooters. “F” and “G” shooters will compete separately.

Rifles: All rifles used in the match must comply with either the *NRA F-Class Open Rifle (F-O)*, rule 3.4 (a) or *F-Class Target Rifle (F-TR)*, rule 3.4 (b) specifications. If a competitor’s rifle meets both qualifications the shooter must state in advance in which category they are competing in.

Ammunition: Competitors must provide their own ammunition. Rifles are restricted to a bore diameter of no larger than .35 caliber. No tracer or armor piercing ammunition is permitted. Surplus military type ball ammo is allowed.

Rules: NRA High Power Competition Rules, Section 22. F-Class Rifle Rules will apply, except as noted.

Targets/Pits: Competitors will take turns servicing targets in the target pits or provide a substitute target puller.

Number of Relays / Number of Firing Points: 2 to 4 relays / up to 9 shooters per relay.

Entry Fees:

Competitors who are a current member of a Michigan or Wisconsin Shooting or Sportsmen’s Club and also a NRA Member in good standing.	\$20.00
All other Competitors	\$25.00
